

Exodus Visa Information for Travel to India

VISA APPLICATION PROCESS SUMMARY

Do I need a visa in advance?

Yes. You can either apply for either:

- Indian eVisa (recommended) – online application
- Standard Visa – requires an in-person visit to VFS (Visa Facilitation Service)

Visa costs:

Indian eVisa:

Please note, these prices are to be used as a guide and may be subject to change.

30 days validity:

- US \$10 (if travelling between April to June)
- US \$ 25 (if travelling between July to March)

1 Year validity visa:

- US \$ 40 + 2.5% bank transaction fee

Standard Visa (1-Year):

- £116 + £15 VFS service charge _ £3 Consular Surcharge
- Optional: £15 courier fee if not collecting passport in person

(Prices may be higher if you are using Visa Service Agency, for example Travcour)

IMPORTANT NOTES:

We recommend applying for a 1-Year eVisa.

All eVisas must be applied for online at least 4-days before arrival. Further details on when to apply are below.

If your trip includes Ladakh or Sikkim, do not mention these locations on your visa application. Doing so can cause delays or even rejection.

Requirements for application:

- Passport photo (2x2 inches)
- Photocopy of passport bio page
- Referee/Indian reference (provided at the end of this document in appendix)
- Previous Indian Visa reference number (if applicable)

When to apply:

Indian eVisa:

- 30-days eVisa: Apply 4-30 days before travel
- 1-year eVisa: Apply up to 120 days before travel

Standard Visa (1-Year)*:

- Apply 8-12 weeks before travel

* Standard Visa – Important Note:

Appointments at VFS/BLS can experience lengthy delays, so book your in-person slot as early as possible to avoid issues.

Processing time

Indian eVisa:

eVisa will be issued up to 72-hours after payment is made and confirmation email received

Standard Visa (1-Year):

7-10 working days from appointment date

VISA APPLICATION OPTIONS

You can apply for your Indian Visa in two ways:

- **e-Tourist Visa (recommended)** – apply online.
- **Standard Visa via VFS (VISA FACILITATION SERVICE)** – Requires an in-person appointment.

You may also use a Visa Service Agency like [Travcour](#) for Standard Visa applications, but note this still requires an in-person appointment, if you use an agency.

IMPORTANT NOTES

Pakistani Passport holders, or those of Pakistani descent: Allow extra time to prepare additional documents for visa processing.

Photo requirement: 2" x 2" (50mm x 50mm), available at most Post Office or photo booths.

VISA TYPES

e-Tourist Visa

- **30-day eVisa:** This is a double entry visa, and is valid for entry to India within 30-days from the date your eVisa is granted. You can only apply for this type of visa only within 30-days of travel.
- **1-year eVisa:** This is a multiple entry visa, and is only valid for 1-year from the date your visa is issued. You can apply for this type of visa within 180-days of travel.

Standard Visa via VFS

- If applying for a visa through VFS, all applicants must complete an [online form](#), then submit the printed form and documents **in person** at your chosen branch of the Indian High Commission's Visa Facilitation Service (VFS).
 - **Online submission alone does not complete your application process.**
 - To complete your online form, you'll need:
 - Two referee details (one at home, one in India)
 - Start hotel details
 - All details for your start hotel and referee in India are provided below.
 - British Passport Holders whose parents were not born in the UK, should check conditions with the Indian Embassy

APPLYING FOR YOUR VISA

Please see the Appendix section for all in-country details required to complete your visa application*

Option 1: eVisa (Recommended)

Before You Start

- Check you meet all requirements for application, especially around the entry points and type of visa available.
- Prepare:
 - Digital passport photo (2x2 inches, specific size requirements)
 - Passport bio page scan
 - Reference Name in home country
 - Reference Name in India section, please see below relating to your Trip Code.

Application Process

- Visit the official portal: <https://indianvisaonline.gov.in/evisa/tvoa.html>
 - Read the instructions carefully, and review the [Sample eVisa Form](#).
 - This provides guidance on how to apply, and information that you will need for your application.
 - Complete the online application form.
 - Pay the fee online (credit/debit card)
 - Receive confirmation email, and eVisa within 72 hours.

Option 2: Standard Visa via VFS

Before You Start

Prepare:

- Digital passport photo (2x2 inches, specific size requirements)
- Passport bio page scan
- Reference Name in home country
- Reference Name in India section, please see below relating to your Trip Code.

Two-Stage Process

Step 1: Complete Online Application

To apply for the Indian visa, you need to go through the relevant Indian High Commission's Visa Facilitation Service VFS/BLS website:

1. Complete the application and declaration forms.
2. You can choose to pay for the visa online **or** at the appointment.
3. At the end of the online application process, you will need to make an appointment at your nearest branch to submit the application.
4. Print your application form.

Step 2: Attend Your Appointment

Visit your chosen visa application Centre at the time of the appointment. You will need to submit the following:

- a. Printed application form
- b. Photocopy of the photo page of your passport
- c. The signed declaration
- d. A hard copy passport photo (2x2 inches)

Submit the documents and pay the visa fee (if not already paid online)

A family member or nominee is entitled to submit a visa application on behalf of the applicant, provided they have a letter of authorization signed by the applicant

NEED HELP APPLYING?

- The easiest way is to apply online through the official **Indian government eVisa portal** (see link and steps in the *Applying for Your Visa* section).
- For trip-specific details (like hotel addresses and references), check the **Appendix** in this document.
- For specific questions, contact the **Indian Embassy** or if you're applying via a Visa Service Agency (Standard Visas Only) contact

them directly.

PHOTO GUIDELINES

When preparing your visa application, it's essential to ensure that your passport photos meet the specified requirements. Follow these steps to resize your photos effectively:

1. **Use Image Editing Software:** Instead of struggling with manual resizing, use image editing software. The Paint app on Windows computers or laptops is a suitable choice as well as the Preview App on Mac computers.
2. **Open the Photo in Paint:**
 - a. Launch the Paint app.
 - b. Open the picture you want to resize.
3. **Select the Resize Option:**
 - a. Look for the "Resize" button. It's usually located under the "View" tab.
 - b. Click on it.
4. **Adjust the Dimensions:**
 - a. In the Resize dialog, you'll see percentage fields for both horizontal and vertical dimensions.
 - b. Enter a value lower than 100 (e.g., 80) to reduce the photo size.
 - c. Click "Select" to apply the changes.
5. **Save the Resized Photo:**
 - a. Save the modified photo in a secure file you use often.
 - b. Close the Paint app.
6. **Check the File Size:**
 - a. Navigate to the location where you saved the file.
 - b. Verify that the photo now meets the recommended size (usually 1 MB or below).
 - c. This can be found on the right-hand side of the file if you have files saved under the detailed tab or alternatively if you hover over the document, it will specify the file size.

Remember to follow any additional guidelines provided by the visa website. By adhering to these steps, you'll ensure that your passport photos are professionally resized for your visa application.

SMALL PRINT

*All nationalities require a full passport that must be valid for 6 months beyond the intended length of stay and need to **be within 10 years from date of issue**. It is your responsibility to have the correct personal documents and to obtain your own visa, if one is necessary, in accordance with the regulations of the country you are to visit.*

If a visa is required prior to travel, it is your responsibility to obtain one. However, we strongly advise you not to do this until your trip has been confirmed as a guaranteed departure. The information above is meant to aid you in getting your visa. Information can change, so if you are at all concerned, please check with the embassy.
